C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

4. Wetlands directly abutting an RPW that flow directly or indirectly into TNWs.

Wetland 1 directly abuts Knickerbocker Lake, which flows northerly into a perennial stream. This stream is being considered perennial because it is a mapped tributary shown on USGS mapping. The stream continues to flow 0.75 miles and enters a culvert under Route 9 and continues flowing north for approximately 0.65± miles and enters a culvert under the railroad tracks and enters the perennial stream known as the Muitzes Kill. The Muitzes Kill is being considered perennial because it is a named tributary shown on USGS mapping. The Muitzes Kill continues to flow north westerly for approximately 7 miles where it discharges to Schodack Creek, which is the closest navigable waterway to the subject property. Schodack Creek ultimately discharges to the Hudson River. Wetland 2 is approximately 0.39± acres onsite and has mixed cover types consisting of emergent, scrub shrub and forested wetlands. Wetland 2 flows north easterly off the parcel and enters a perennial stream. This stream is being considered perennial because of it is a mapped stream shown on USGS mapping. The stream continues to flow westerly for approximately 0.20± miles and enters Wetland 1.**
