approximately 0.34 miles from and 100 feet higher than the Saddle River to the east, the nearest waters of the U.S. Wetland A and Wetland B appear to have an ephemeral connection via topographic depression that runs slightly northeast to slightly southwest. Topography suggests the ephemeral channel continues southeast beneath Hillside Avenue; however, there is no apparent hydrologic connection to waters of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Rockland County GIS's two-foot topographic contour lines indicate the site has a relatively gradual slope southeast toward the eastern property boundary. The USFWS National Wetland Inventory Map indicates one (1) forested freshwater wetland within the subject parcel. Soils on-site are characterized as silt loam and urban land complex, which are both well drained.

An initial JD delineation by the applicant, conducted on November 10, 2020, indicated two (2) wetlands, totaling 0.4 acres within the 19.4 acre site. Wetland A was shown to extend off-site to the west, and Wetland B was delineated south of Wetland A. Site topography suggests a channel between the two delineated wetlands and continuing southeast beyond Wetland B. The topo immediately around Wetland B is relatively flat. No hydrologic surface water connections were identified in the 2020 delineation. USEPA conducted a site visit on March 18, 2022 to investigate an alleged fill violation. During the site visit, standing water was noted between Wetlands A and B, but hydric soils were not found. An additional delineation was conducted by the applicant on June 28, 2022. Two additional test pits were evaluated and found not to be wetlands because at least one of the criteria (vegetation, soils, hydrology) were not satisfied. Again, no hydrologic surface water connections were identified. The site does not have any defined stream beds or banks between the two wetlands. There is a small channel at the southern portion of the property, south of Wetland B that has been dry each time the site was delineated, including the USEPA's March 18, 2022 site inspection which followed a rain event. Based on the available information, this small channel is ephemeral.

Based on the lack of hydrologic surface water connection to an (a)(1)-(a)(4) water, these two wetlands are non-adjacent and, therefore, do not meet the current definition of waters of the United States.
