### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):**

If potential wetlands were assessed within the review area, these areas did not meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or appropriate Regional Supplements.

Other: (explain, if not covered above): **There is one isolated wetland, identified as Wetland Z, that totals 0.09 acre within the jurisdictional determination boundary. The wetland is located in the southwestern portion of the review area and is a small wetland that is located entirely on the site. Wetland Z is located approximately 645 feet away from the nearest stream, and over 50 feet away from the nearest jurisdictional wetland (Wetland 1). Wetland Z is outside of the mapped 100 year floodplain of, and at least 29 feet higher in elevation than Drummond Creek, which is on the property but outside of the jurisdictional determination review area. Uplands surround Wetland Z and there are no natural or man-made discrete or confined surface hydrological connections between Wetland Z and Wetland 1, nor any of the other jurisdictional waters located on or near the site. As noted above, Wetland Z is not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetland. The wetland would not be considered a traditional navigable water in that it does not have the necessary water depths to support navigation of any kind, and does not have any surface hydrologic connection to a waterbody that would. The wetland does not cross or serve as any state boundary and does not have a use that would associate it with interstate commerce.**
