### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Other: (explain, if not covered above): **There are eight (8) isolated wetlands, identified as Wetlands A through H, that total 3.75 acres within the jurisdictional determination boundary. All of the wetlands are located within maturely and densely forested areas. Wetlands B, C, D, E, F and H are located entirely within the JD boundary. Wetland A extends off-site to the west briefly where it ceases along off-site railroad tracks. There are no culverts, ditches, wetlands or other surface features that connect Wetland A to any on or off-site waters of the United States. Wetland A also slopes toward the east, which is away from the tracks. Wetland G continues off-site to the southeast and ceases well before reaching jurisdictional Wetland 3 where it would extend off-site. Wetlands D through H are a series of pools that decrease in elevation heading north. All but Wetland G have sparsely vegetated surfaces. Wetlands A through H are all located a minimum of 100 feet from the nearest jurisdictional wetlands, and range in distances from 154 feet to 351 feet from the nearest jurisdictional streams or pond. For all 8 areas, each wetland is surrounded by uplands and ridges that have not been manipulated to cause these wetlands to become disconnected from any jurisdictional waters. There are no natural or man-made discrete or confined surface hydrological connections between the 8 isolated wetlands and any jurisdictional waters. Wetlands A through H are not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The USACE site inspection and several inspections conducted by the applicant's consultants confirmed that there is no physical evidence of flooding from the tributaries to the isolated wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. These wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**
