C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

It should be noted that the same perennial stream within Wetland 1 (Stream 1) and outflowing from Open Waters 1 (Stream 2), is the same perennial stream entering Stream 4 and Wetland 5 to the east. There is a separation at the surface, with an abandoned channel present, due to man-made alteration. The stream currently flows underground between Wetland 1/Open Waters 1 and Wetland 5. The entire reach of the stream is perennial with a man-made discontinuity in the ordinary high water mark. Both on-site ponds exhibit year-round flow. One pond was constructed within

the stream within Wetland 1, and the other was constructed in wetlands. All of the streams flow off-site to the east and enter the Snook Kill, which is located just off-site.
