C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **There are two isolated wetlands on the referenced delineation map within the limits of jurisdictional determination. These wetlands are identified as "Wetland Area 1" and "Wetland Area 2" and consist of a total of 1.11 acres in area. Both wetlands are located entirely within the subject property and in the northeast portion of the jurisdictional review area. Wetland Area 1 is a palustrine open water wetland that is positioned within a natural topographical depression that was likely deepened by prior mining activities. Wetland Area 1 is at least 2,000 feet from the nearest jurisdictional aquatic resource. Wetland Area 2 is a smaller palustrine open water resource located at the northeast of Wetland Area 1. It is also located within a topographical depression and is at least 2,000 feet from the nearest jurisdictional aquatic resource. Based on observations in the field, neither of these wetlands have any direct hydrological surface connections to any other aquatic resource or to each other. There are no natural or man-made surface features that connect these wetlands to any other aquatic resources. Neither the subject wetlands, nor the site is located within the mapped 100 year flood plain. Therefore in times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. Neither of these wetlands would be considered traditional navigable waters in that they do not have the necessary depths to support navigation of any kind, and do not have a hydrological connection to any waterbody that would. These wetlands do not cross or serve as any state or international boundary, and they do not have a use that would associate them with interstate commerce.**
