property was historically mined for sand and gravel and has been filled and graded. The wetland areas are located at the toe of slope of fill berms, confined within defined, topographic depressions that are located along the western property boundary. These depressions, which were created as a result of the former mining activities that occurred on the site, are seasonally/ephemerally inundated (during spring thaw and immediately after heavy precipitation events). Forested upland berms extend between these wetlands and an old road (constructed along the berms), which separates them from two larger ponds that are located immediately west of the site. Ephemeral flow (originating from the off-site ponds) was observed flowing along the surface of the ground, across the old road, and into Wetland Area C. No flow of water between the ponds and Wetlands A or B was observed. No culverts or other sub-surface drainages or collection systems were identified. The two off-site ponds are also apparently man-made impoundments that were constructed between 1947 and 1964, likely as a result of other mining activities undertaken. No evidence was found indicating the two ponds have an apparent, discrete, unbroken surface or shallow sub-surface hydrologic connection with any tributary to navigable waters. The wetlands are located at least 1,100 feet from and 23 feet higher in elevation than the closest tributary and wetland complex, with no apparent, discrete, unbroken surface or shallow sub-surface hydrologic connection. Wetlands A, B and C are also not reasonably close to or separated by a dike, barrier, berm or similar from a tributary. There are no features within Wetlands A, B and C which are or could be used by interstate or foreign travelers for recreational or other purposes. There are no areas from which fish or shellfish can be or are taken and sold in interstate or foreign commerce. There are no areas which are or could be used for industrial purpose by industries in interstate commerce. Consequently, there does not appear to be a reasonable nexus with interstate commerce. Also, the use, degradation or loss of Wetlands A, B and C will not affect other waters of the U.S. or affect interstate or foreign commerce.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
