C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):

 - Other: (explain, if not covered above): **There are two isolated wetlands, identified as Wetlands A and B, that total 0.10 acre on the property. The wetlands are located near each other, between Wetlands 1 and 2 within the northeastern portion of the site. Isolated Wetlands A and B are located entirely within the property boundary and slope toward the northeastern site boundary that lies along an overhead utility line right-of-way. Wetland A is closest to the property boundary. There is a natural rise in elevation between the wetland that reaches the property boundary. Wetland A does not continue off-site to reach the wetlands within the ROW, nor does it connect with Wetlands 1 or 2, or the streams within those wetlands. Wetland A is at least 167 feet from Stream 1 and 140 feet from Stream 2, and lies at least 2 feet higher in elevation than the streams. Wetland B was previously determined to be isolated and non-jurisdictional in an approved jurisdictional determination issued by this office on March 14, 2012 (NAN-2007-00332-YN). After the JD was issued, it was indicated that the wetland was filled, however, at the time of the July 26, 2022, site inspection, the area was confirmed to be wetlands. Wetland B continues to be isolated, and is located at least 125 feet from Stream 1 and 160 feet from Stream 2. Wetland B is at least 6 feet higher in elevation than these streams. For both wetlands, they are surrounded by uplands that have not been manipulated to cause them to be disconnected from any jurisdictional waters. There are no natural or man-made discrete or confined surface hydrological connections between the two isolated wetlands and any jurisdictional waters. Wetlands A and B are not located with a 100-year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**
