C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):

 - Other: (explain, if not covered above): **There is one isolated wetland, identified as Wetland A, which totals 0.011 acre within the property boundary. Wetland A is located in the northwest corner of the site and is at least 375 feet away from the nearest jurisdictional tributary (Spring Run), and at least 29 feet higher in elevation than Spring Run. Wetland A is relatively flat and continues off-site to the west, where it ceases before Excelsior Spring Avenue. There are no drainage ditches or culverts present along or under this road to provide a physical connection to any jurisdictional waters. Directly across the street, uplands are present at the same elevation as Wetland A. Further to the southwest, there is a wetland complex that abuts Spring Run which lies at much lower elevations than Wetland A. A catch basin and storm drain was found within Excelsior Spring Road in the project vicinity during the USACE site inspection, however the drain does not outlet to Spring Run in this area. The piping is also not directly connected to Wetland A. There are no natural or man-made discrete or confined surface hydrological connections between Wetland A and any jurisdictional waters. Wetland A is not located within the 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into Wetland A. The wetland would not be considered a traditional navigable water in that it does not have the necessary water depths to support navigation of any kind, and does not have a surface hydrologic connection to a waterbody that would. Wetland A does not cross or serve as any state boundary and does not have a use that would associate it with interstate commerce.**
